

## **Guidance Notes on Application for School Fee Remission 2024-2025**

The aim of the scheme is to provide school fee remission to children of needy families. This is a family-based application. Each family is only required to submit ONE application.

#### 1. Application Procedures

- a. Application form can be downloaded from the school website (http://www.puikiucollege.edu.hk) or obtained from the General Office.
- b. The completed application form, together with \*supporting documents, should be mailed / returned to Pui Kiu College on or before 30 September 2024 (Address: 1 Tai Wai New Village Road, Tai Wai, Shatin, N.T.)
  - \* One of the following documents should be attached to the application form:

#### (I) For students who are admitted in 2017-18 school year or before

- ➤ Application for Full Fee Remission
  - The application result notification for *School Textbook Assistance* issued by the SFO.Irrespective of the level of *School Textbook Assistance* (full or half) assessed by the SFO, our school will approve full fee remission to the students concerned
  - Comprehensive Social Security Assistance (CSSA) Scheme notification letter
- ➤ Application for Half Fee Remission
  - Tax return of the year 2023-24
  - Salary advice
  - Other documents reflecting the financial situation
  - Amount of school fee remission is subject to the financial situation of the applicant's family. For families with income, please refer to the tables below for the methods of assessment

#### (II)For students who are admitted in 2018-19 school year or thereafter

- ➤ Application for School Fee Remission
  - The application result notification for *School Textbook Assistance* issued by the SFO.Full or half fee remission will be approved according to the level of assistance (full or half) assessed by the SFO and stated in the notification
  - Comprehensive Social Security Assistance (CSSA) Scheme notification letter
- c. Those have obtained other types of financial assistance (such as Local Education Allowance, etc) may also apply but details of the assistance have to be provided.
- 2. Special approval for school fee remission will be granted for cases of families with 7 or more members/families with special financial difficulties.
- 3. In case of disputes, Pui Kiu College reserves the right to make the final decision.

# **Areas of Attention / Supplementary Information**

Generally speaking, in order that the application result notification for *School Textbook Assistance* could be issued earlier, parents should submit their applications to the SFO by 31 May. #### **Appeal Mechanism**

If applicants are dissatisfied with the result of their assessment, they may apply in writing to the school for reassessment, specifying in the written request the application number or the name of the students, and providing detailed justifications and any documentary evidence in support of their application. The application for reassessment must be duly signed by the applicants.

Re-assessment of eligibility normally takes three months to process. Since longer processing time will be needed for re-assessment, applicants should apply as promptly as possible for re-assessment within one month from the issue date of the notification of result.
